Pairings Proxy Bid Authorization Terms and Conditions

The following represents the agreement between the absentee bidder named below and the Nashville Wine Auction for Pairings to be held on February 24, 2018.

1. I understand I must be 21 years old or over to bid in the auction.
2. I understand that I will receive a text on my mobile phone on February 20, 2018, and am responsible for bidding on Silent Auction items using Mobile Bidding.
3. With my signature below I authorize the Volunteer Proxy Bidder representative from the Nashville Wine Auction to bid on my behalf for the Live Auction items I have designated on the attached page of this form at Pairings on February 24, 2018.
4. I understand that all Auction Lots are subject to the rules of the auction and in accordance with the catalog statements.
5. I understand that my bid will be executed at the lowest dollar amount possible as allowed by starting bid amount and other bids.
6. I understand the Nashville Wine Auction Volunteer Proxy Bidder representing my interests will bid aggressively to avoid the risk of losing an Auction Lot to a more active bidder and will not bid higher than needed to win an Auction Lot.
7. I understand the Volunteer Proxy bidder will not exceed my maximum bid for any Auction Lot.
8. I understand that if two bids are made for the same item, the bidder who submitted their bid first will win the item.
9. If my proxy bid is the highest made for Auction Lot(s) I have designated on the attached page, I will win the Auction Lot(s). I authorize my credit card to be charged for that amount.
10. I understand that my submission of this Proxy Bid Form is final and may not be altered as of noon on Friday, February 23, 2018.
11. I understand that the State of Tennessee prohibits Nashville Wine Auction from shipping wines. Therefore I agree that my purchases must be picked up from the Nashville Wine Auction office within 90 days of February 24, 2018.
